Breast reconstructive surgery after a mastectomy.

Surgery to restore a breast to near normal shape, appearance, and size (breast reconstructive surgery) after a mastectomy is covered. This includes:

- Reconstructive surgery for a cancerous breast.
- Reconstructive surgery for a breast without cancer so that the breasts are the same size and shape (to make them symmetrical). This surgery is covered as long as it is done within five years of the reconstructive surgery on the diseased breast.

Chlamydia screening

One annual chlamydia screening test combined with an annual Pap smear are covered for females who are **29 years of age and younger**.

Chiropractic services

Services are covered if they are a cost-effective alternative. For adults age 21 and older.

Community-based residential alternatives

The following medically necessary community-based residential alternatives are covered for CHOICES members in Group 3:

- Community living supports (CLS) housing
- Assisted care living facilities
- Companion care
- Adult care homes

Diabetic services

The following diabetic services are covered:

- Equipment
- Supplies
- Outpatient self-management training and education. This includes medical nutrition counseling when medically necessary.

Inpatient rehabilitation hospital facility services

- For children under age 21: Services are covered as medically necessary.
- For adults age 21 and older: Services are not covered, unless determined to be a cost-effective alternative.

Nursing facility care

Covered for medically necessary nursing facility care on a short-term basis (up to 90 days). For CHOICES members in Groups 2 and 3 and ECF CHOICES members in Groups 4, 5, and 6.

Occupational therapy

Services from a licensed occupational therapist to restore, improve, or stabilize impaired functions are covered. For adults age 21 and older.

Organ and tissue transplants and donor organ procurements

Organ and tissue transplants and donor organ procurements are covered. For **adults age 21 and older and children under age 21.**

Physical therapy

Services by a licensed physical therapist to restore, improve, or stabilize impaired functions are covered. For adults age 21 and older.

Physician outpatient services/Community health clinic services/Other clinic service Covered for adults age 21 and older and children under age 21.

Phenylketonuria (PKU)

Treatment of PKU is covered. This includes licensed professional medical services and special dietary formulas.

Speech therapy

If medically necessary, services from a licensed speech therapist to restore speech after a loss or impairment are covered (as long as there is continued medical progress). The loss or impairment must not be caused by a mental, psychoneurotic, or personality disorder. **For adults age 21 and older.**
